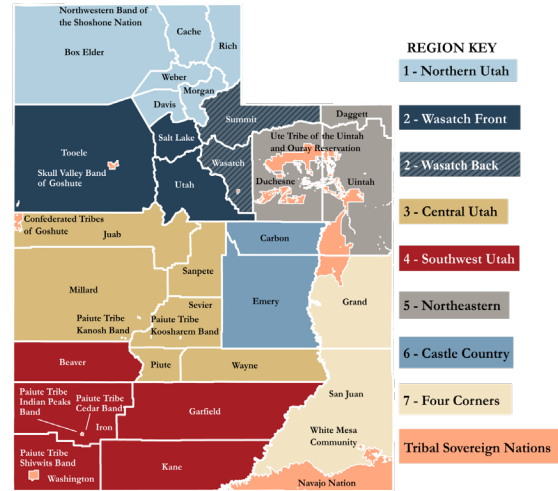

Significant State Activity

Other Immediate Concerns

- **Active** The most significant rises are forecasted for the South Fork of Ogden River and Sevier River near Hatch. [See Flood Warnings here](#) [NWS Twitter]
- **Active** Current flood risk is spring runoff, increasing streamflows, and snowmelt. Some reported flood-related landslides are being monitored.

- **Active** May 1st [Utah Water Supply Outlook Report](#) by the Natural Resources Conservation Service (NRCS)
- **Update** Activated Emergency Support Functions: ESF #1, ESF #3, ESF #5, ESF #7, ESF #11, ESF #13, ESF #14, ESF #15, ESF #16, Logistics, VDCT, Volunteer Agency Liaison (VAL), VOAD, Finance, and Air Operations.

Current Operational Requests

- **Update** 10 active requests are in progress regarding various other flooding response and mitigation resources, 1 active request is pending additional information for flooding response. *[WebEOC]*

Region 1

Box Elder County

- **New** Monitoring Box Elder Creek down through Brigham City. *[LNO Correspondence]*
- **New** Bear River went over the river banks on 5/4/23 at 6,500 cfs. PacifiCorp raised release to 8,000 cfs yesterday, with indication levels will go up incrementally through 5/7/23. It takes almost 2 days for flow increases to travel from Cutler Dam to Corinne. All river bottom agricultural lands are currently flooded or will be in the next 24 hours.
 - Communication is occurring with potentially impacted infrastructure: Old Barn Community Theatre, Bear Hollow Ski Resort community, Garland City Culinary Water Facility, Corinne City Sewer Treatment Plant, and one residence. *[LNO Correspondence]*

Weber County

- **New** Ogden City has [declared a local emergency](#), expiring June 2nd. *[LNO Correspondence]*
- **Update** The Bureau of Reclamation is actively monitoring the Causey Reservoir, overflow into the spillway began during the morning of 5/4/23 and is ongoing. Residents did a lot of sandbagging. The emergency manager is attempting to contact 1 private residence that is now affected by water and was not sandbagged. This may be a secondary residence. *[Bureau of Reclamation, LNO Correspondence]*

Cache County

- **Active** The Bureau of Reclamation, Utah Division of Water Resources, and Cache County are actively monitoring the Hyrum Dam for potential high-flow releases in the Little Bear River. *[Bureau of Reclamation, Interagency Correspondence]*
- **Active** Due to the heavy snowpack, the county has also determined that extending the seasonal restrictions on county roads to motorized vehicles is necessary and appropriate until at least May 15th. *[Cache County]*

Rich County

- **Update** UDAF officials estimate that 20-30 ranches along the Bear River have been impacted by flooding. As a result of this emergency, cattle have been evacuated to avoid the rising waters. Some cattle have been lost. UDAF has not yet determined the total number of cattle lost. [Read more](#) *[UDAF]*

Region 2

Salt Lake County

- **New** SR-210 closed at MP 7 in Little Cottonwood Canyon (LCC) due to a second mudslide. The road has since reopened, with extra safety measures during the day. *[UDOT, UDOT Cottonwood Canyons, LNO Correspondence]*
- **Active** Sugar House Park will be closed to vehicles through at least May 14th as controlled releases from Mountain Dell and Little Dell Reservoirs continue. *[SLCo Parks & Recreation Twitter]*
- **Active** SR-190 and SR-210 are being monitored and assessed daily to determine if/when road closures are needed for land/mudslides, avalanches, or other hazards. Closures are possible at any time, be prepared & check the road status. *[UDOT Cottonwood Canyons]*

Utah County

- **Active** Nightly closures of SR-89 at MP 311 are expected. *[UDOT]*

Region 3

- No significant updates to report at this time.

Region 4

Beaver County

- **New** Beaver River is running between 165-185 cfs and is starting to max out at times. [LNO Correspondence]
- **New** Minersville Lake is filling back up very quickly. [LNO Correspondence]

Garfield County

- **New** Sevier River flow is dropping slightly as of the morning of 5/5/23. [LNO Correspondence]
- **Active** Old Town Hatch - Structures threatened. The river banks are eroding quickly due to the water taking out the trees that hold the banks. [LNO Correspondence]
- **Active** Road closure at John's Valley Road thru Black Canyon south of Antimony due to flooding. [LNO Correspondence]

Iron County

- **New** Coal Creek is running at 212 cfs, well within tolerance. [LNO Correspondence]
- **New** Little Salt Lake is filling up after being dry for about 10 years. [LNO Correspondence]
- **New** Southern Utah University (SUU) Aviation will do drone flights up the county channels to identify problem areas, beginning 5/5/23 or 5/6/23. [LNO Correspondence]

Kane County

- **New** Two subdivisions on Cedar Mountain are still experiencing water-covered roads and high flows, but no homes or people are threatened. [LNO Correspondence]

Washington County

- **New** IRONMAN Planned Event - The State Mobile Command Vehicle and the Communications Van arrived on 5/4/23. DEM logistics personnel will be staffing these for the duration of the event. [LNO Correspondence]
- **New** River flows are dropping. [LNO Correspondence]

Region 5

Uintah County

- **New** Green River in Jensen is anticipated to peak flood stage this weekend. Sand and sandbags are available in Jensen. [LNO Correspondence]

Region 6/7

Carbon County

- **New** Some concern with Clear Creek flowing into the Scofield Reservoir. The local emergency manager will assess at the beginning of next week. [LNO Correspondence]

Grand County

- **New** Water is flowing over the roadway at Stocks Drive. [LNO Correspondence]
- **New** Water is flowing over the low water crossing at Sunny Acres. [LNO Correspondence]

San Juan County

- **New** Shares concerns with Sunny Acres, crews are working on mitigation efforts. [LNO Correspondence]

Tribal Nations

- No significant updates to report at this time.

- **Active Flood Warnings** are in effect in the following areas:
 - Sevier River near Hatch
 - South Fork of the Ogden River near Huntsville
- **Active Flood Advisory** is in effect for the following area:
 - Bear River at Corinne
- **Active Flood Watches** are in effect in the following areas:
 - Lower Weber near Plain City
 - Cache Valley, including the Little Bear River below Hyrum Reservoir
- **Active:**
 - Temperatures will remain below seasonal normals through the weekend, reducing impacts from snowmelt.
 - A combination of increased releases and snowmelt may cause the Little Bear River below Hyrum Reservoir to Cutler Reservoir to exceed safe channel capacity. Minor flooding is possible in these areas.

A MINOR (1/4) Weather Risk means...
A rapid change in temperatures will cause significant rises on area creeks and streams

What to expect...

Snowmelt and increased reservoir releases will cause the river flows to become high. Expect minor flooding downstream from Cutler Dam.

- Minor Flooding will occur to agricultural land and associated roads adjacent to the **Bear River** near the Great Salt Lake
- The river is expected to rise to a crest of 15.1 feet or 7600 cfs Monday morning. Flood stage is 15.5 ft or 8211 cfs.

What to do...

If you are in the flood plain, consider strategies to mitigate damage including sandbags or relocating property to higher ground.

Use caution in any areas impacted by flood waters. Turn around, don't drown!
